Theses in American Studies for Norwegian University Degrees 1908-69

Below are listed theses on American subjects presented to the departments of English and History in the universities of Oslo and Bergen.

The Norwegian higher degree in English is based on a lower degree (mellomfag) where English been studied for three semesters and is one of three so-called minor subjects required for the Cand.mag. degree. Studies in English on the higher level oomprise courses in English and American literature, a course in linguistics, a study of Old and Middle English set texts. and exeraises in 'translation (Norwegian-English). The average bime required for the preparation of the »hovedfag* (main subject) is four semesters. This also includes the writing of a thesis. As may be seen from the listed titles the theses are now usually written in English. The average length of a thesis is 60-80 typewritten pages. In his work on his thesis the student is introduced to research methods and techniques. He learns the process of gathering and preparing material for publication. New results are not required in a thesis on this level, though it does happen that a student in his thesis makes an original contribution to resaarch. Having fulfilled the above requirements the candidate receives the degree Cand.philol. In section A below are listed the theses written on American subjects since 1908. The growing interest in American studies is notable.

Some students work for the Magister's degree instead of the Cand. philol. degree. The student must then submit a thesis where more of personal and independent research work is required. The work with the Magister's degree gives the student a greater opportunity for specialized studies. The theses submitted for the Magister's degree (Mag. art.) are listed in section B.

The higher degree (Cand.philol.) and the Magister's degree in *History* correspond to that in English.

The Norwegian doctorate does not form part of the ordinary examination system, but is an independent contribution to research. Before presenting his dissertation the candidate must have passed his Cand. philol. examination with the mark laudabilis. He has to give two public lectures, and he has to defend his dissertation at a public disputatio. The few Norwegian doctoral dissertations in American Studies are listed below in section C.

Copies af theses and dissertations are deposited in the University Libranies, at times with a stipulation that the material must not be used without the consent of the author. If no other information is given, the thesis was presented at Oslo. Place and time of publication in print are given where such information was available.
