**Pirjo Ahokas** is Professor of Comparative Literature at the University of Turku, Finland. She began her academic career by focusing on Jewish American fiction. She is also the author of *Forging a New Self*, a monograph on Bernard Malamud's novels, and co-editor (with Martine Chard-Hutchinson) of *Reclaiming Memory: American Representations of the Holocaust*. Her subsequent research deals with works by American women authors of Chinese, African American and Native American descent. She has also concentrated on new writing by "Black" British women authors and compared their works with those by contemporary American ethnic minority women authors.

**Niels Bjerre-Poulsen** holds a Ph.D. in American History from University of California, Santa Barbara, and is Associate Professor at the Center for American Studies, University of Southern Denmark. He has published widely on topics related to American political culture and foreign relations. His most recent book is *Vietnamkrigen, 1945-1975: En International Historie* (Copenhagen: Gyldendal, 2015). Niels Bjerre-Poulsen is also a former president of NAAS, and he frequently comments on American politics in the Danish media.

**Benita Heiskanen**, PhD, is Director of the John Morton Center for North American Studies and Docent of American Studies at the University of Turku.
