Rani-Henrik Andersson is a Senior University Lecturer of North American Studies at the University of Helsinki. He served as the interim McDonnell Douglas Professor of American Studies (2014-2016), and CORE Fellow at the Helsinki Collegium. He has authored or edited 11 books, including *The Lakota Ghost Dance of 1890* and *A Whirlwind Passed Through Our Country*. His recent works include *Lakǎóta: An Indigenous History* (2022) and *Finnish Settler Colonialism in North America* (2022).

Dag Blanck is Professor of North American Studies at Uppsala University. He also serves as Director of the Swenson Swedish Immigration Research Center at Augustana College in Rock Island, Illinois. He has published a dozen books and some 50 articles on American immigration history and Swedish-American relations.

Jenny Bonnevier is Associate Professor of English at Örebro University. Her research focuses contemporary American popular culture, in particular speculative fiction, and feminist and critical posthumanist theory. She is the co-editor of *Kinship in the Fiction of N.K. Jemisin: Relations of Power and Resistance* (2023). She served as the President of the Swedish Association for American Studies 2012-2016 and 2020-2024.

Myrto Drizou is Associate Professor of English at Nord University, Norway. Her research focuses on American literature, gender studies, and historical approaches to American culture. She has published widely on Edith Wharton and other realist and naturalist authors. She serves as President of the Edith Wharton Society and Associate Editor of the *Edith Wharton Review*.

Cassandra Falke is a Professor of English Literature at UiT – The Arctic University of Norway – and a Fellow of Cornell University's Society for the Humanities. From 2018-2022, she was the President of the American Studies Association of Norway. She has authored around fifty articles and book chapters and two monographs on romanticism, class, violence and education, as well as editing four essay collections. Her work has received support from the Fulbright Foundation, NEH and NOS-HS.

Joel Frykholm is Associate Professor of Cinema Studies at Stockholm University. He is author of *George Kleine and American Cinema* (BFI, 2015) and co-editor (with Marina Dahlquist) of *The Institutionalization of Educational Cinema* (Indiana University Press,

2019). Current research interests include Swedish cinema history, Swedish contemporary film and television culture, and Swedish responses to the global impact of American popular culture from cinema's silent era onward.

Adam Hjorthén is Associate Professor of History and Senior Lecturer in American Studies at the Swedish Institute for North American Studies, Uppsala University. He specializes in studies of U.S. cultural memory and Swedish-American relations, and is author of *Cross-Border Commemorations: Celebrating Swedish Settlement in America* (University of Massachusetts Press, 2018), and co-editor of *Swedish-American Borderlands: New Histories of Transatlantic Relations* (University of Minnesota Press, 2021).

Cathryn Halverson is a Senior Lecturer (docent) in English at Södertörn University. She is the author of several monographs in American literature, including *Faraway Women and the Atlantic Monthly* (2019) and "A Born Writer": Juanita Harrison and Her Beautiful World, 1887-1967, forthcoming in 2025 with the University of Massachusetts Press.

Maren Johnson is Associate Professor of Nordic studies at Luther College in Decorah, Iowa, USA. Her teaching and scholarship focus on participatory pedagogy in the second language classroom.

Saara Kekki is an Academy Research Fellow in Digital Humanities at the University of Helsinki, Finland. Her research interests lie broadly in North American immigration, ethnicities, and historical networks. She is the author of *Japanese Americans at Heart Mountain: Networks, Power, and Everyday Life* (2022).

Christin Mays holds a PhD in Sociology of Education from Uppsala University. Her dissertation investigated the historical development of international scholarship programs and their role in structuring scholarly exchanges between Sweden and the United States in the twentieth century. Mays is currently a research coordinator at the Swedish Institute for North American Studies (SINAS) at Uppsala University.

Erik Mustad is Associate Professor of English at the University of Agder in Norway. He has published widely on British and American history, politics, culture and society for three decades. In recent years he has worked closely on immersion pedagogies and high impact learning strategies. Mustad is also a popular media commentator on British affairs.

Anne Mørk is an independent scholar. She holds a Ph.D. in American Studies from the University of Southern Denmark, where she taught for several years. Her research focus is American democratic culture, including civil society, volunteerism, and political ideologies.

Christophe Premat is an Associate Professor in French Studies at Stockholm University, where he also serves as the head of the Centre for Canadian Studies. In June 2024, he was awarded the International Council for Canadian Studies prize for his research in Canadian studies. Since 2018, he has been the co-editor of the *Nordic Journal of Francophone Studies*.

Stefan Rabitsch is an Associate Professor in American Studies at the University of Oslo, Norway. His main areas of research and teaching straddle American cultural history and popular culture studies across media. Among other things, he is the author of *Star Trek and the British Age of Sail* (McFarland, 2019).
